### Academy Information

**When:** The Cheerleading Academy runs from Term 1 to Term 4 2025. Students compete in Cheerbrandz Eutopia and Cheerbrandz Majors competitions.

Training occurs once a week outside of school hours with day and time to be determined.

**Where:** Competition venues vary throughout the year.

Training occurs weekly at Ausfunk Cheer and Dance Studio, 31 - 33 Runway Drive, Marcoola to the venue must be organised by the student. Students will also need to arrange transport to school after training when conducted before school hours.

**Who:** The Cheerleading Academy is coordinated by Coolum SHS staff. Coaching is conducted by qualified coach Ausfunk Director Hayley Green through our official partnership with Ausfunk Cheer and Dance. Students of all year levels are eligible for entry into the Cheerleading Academy.

**Cost:** \$450 – inclusive of coaching, competition entry costs, and a personalised jersey for each student.

- *Prices listed above are based on current Academy enrolments. Final pricings will be determined and communicated when selection has been finalised for each Academy and may not include all competition fees.*

### Academy Trials

Student selections will be made in consideration of the following written application and students' participation in the Cheerleading Academy Trial in **Term 1, 2025**. Students submitting this form will receive an invitation to trial once a specific date has been selected.

### Payment of Academy Program/s Fees

If your child is a successful applicant, all outstanding school fees must be paid in full or an up to date payment plan in place, approved by the Business Manager. In addition, Academy fees must be paid in full 30 days after the invoice has been issued.
