### Academy Information

**When:** The Netball Academy runs from Term 1 to Term 2 2023 **ONLY**, concluding after the Vicki Wilson Shield. Students compete in the Sunshine Coast School Sport (SCSS) competition, and the Vicki Wilson Shield Carnival with days and times to be confirmed. Training occurs once a week outside of school hours with day and time to be determined.

**Where:** The SCSS competition is at Fishermans Road, Maroochydore precinct and the Vicki Wilson Shield is to be determined. Transport to the venue may need to be organised by the student. Training occurs at Coolum State High School's outdoor courts or multi-purpose hall with day and time to be determined.

**Who:** The Netball Academy is coordinated by Coolum SHS staff and qualified coaches dedicated to our students' success and progression in the game of Netball. Students of all year levels are eligible for entry into the Netball Academy.

**Cost:** \$230 – inclusive of coaching, court hire, competition entry, skill clinics, uniform.

- Please note the viability of each Academy is dependent upon sufficient student interest.
- Prices listed above are based on current Academy enrolments. Final pricings will be determined and communicated when selection has been finalised for each Academy and may not include all competition fees.

### Academy Trials

Please note that there are a number of teams selected for the Netball Academy, with final teams and age divisions being determined by the number of students interested and the consideration of the following written application and students' participation in the Netball Academy Trial. A **Netball Academy Trial Consent Form** must be completed prior to the date of the trials. The trials will be held on:

- Years 7 – 9 applicants will trial on **Friday 10 November 2023** from 4.00pm to 6.00pm at the CDNA.
- Years 10 – 12 applicants will trial on **Friday 17 November 2023** from 4.00pm to 6.00pm at the CDNA.

Submission of this form indicates that you will attend the trial with the appropriate playing gear. Please no previous representation, academy or team uniform to be worn.

### Payment of Academy Program/s Fees

If your child is a successful applicant, all outstanding school fees must be paid in full or an up-to-date payment plan in place, approved by the Business Manager. In addition, Academy fees must be paid in full 14 days after the invoice has been issued.

1. Coordinator and student meeting. Begin to implement an 'intervention plan' where the student can identify areas of support for improvement. Parents will be made aware of this meeting with a telephone call home.
2. Improvement will be monitored by the Coordinator on next term's report card. If improvement is noted, no further intervention is required.
3. A lack of improvement will result in a meeting with parent or guardian, student and the Coolum State High School Academy Coordinator, Mrs Tamika Megawatt. The 'intervention plan' will be reviewed and the student will be made aware that continued failure to meet expectations by the conclusion of the term will result in the student being removed from the academy.

I/We confirm that my child and I understand that if any academy participant is suspended from school they will not be able to participate in the academy during that period.

I understand that as my child has been successfully selected for the Netball Academy 2024, I will be invoiced \$230, which is inclusive of coaching, court hire, school netball competition entry, skill clinics, uniform, but does not include competition registration fee with the Sunshine Coast Secondary Schools Netball Competition or the Vicki Wilson Shield Carnival competition fee.
